Location

Southwest corner of Market Street and South 16th Street. Situated at the nexus of SEPTA's regional rail, subway, trolley, and bus lines.

Recent Renovations

Renovated building entrance and sleek, new lobby; state-of-the art fullservice building gym with showers; upgraded bathrooms and common corridors; bicycle room; monument signage.

Construction

The superstructure is concrete encased structural steel, post and beam supports with metal pan and concrete floors.

Exterior

The facade is clad with limestone spandrels with aluminum and glass window walls separated vertically by limestone panels at structural columns. The grand entrance is bracketed by granite and festooned by granite encased full story lighted bollards.

Lobby

Sleekly redesigned, contemporary lobby with honed marble floors, radiant white panels and porcelain stone walls, cutting-edge lighting to showcase original lobby architecture and ovalar, recessed ceiling, and bold, modernist art installation by artist, Chulhyun Ahn.

Elevators

16 Passenger, 1 Freight, 1 Lobby Escalator.

HVAC

Air conditioning – Central system with rooftop cooling towers and two 1,000 ton centrifugal chillers provides chilled water to nine central air handlers. Heating – Steam is provided to hot water heat exchangers and is distributed to induction fans at the perimeter, and to interior air-handling equipment. Supplemental HVAC – A building-wide condenser water loop is available for all HVAC units.

Health & Safety

Centrally monitored fire alarm system with flow detectors, electronic tamper switches and smoke detectors with back-up generator support. Building is fully sprinkled.

Security

24/7 attended lobby with a Card Key activated turn-style access system, monitored through a Digital CCTV and camera system.
